• Parental concerns about explicit content and its alignment with Catholic values

**Speaker**; Caroline Adamczuk-Sech (DH Teacher) department head of english department presents document regarding the curriculum, assignments and breakdown of the novel

- Novel approved by Alberta Education and Catholic School authorities; taught in Grade 12 only.
- Alignment with 30-1 outcomes and objectives
- Curriculum emphasizes moral, intellectual, and emotional development; novels are used to foster empathy, critical thinking, and moral reflection.
- Explicit content addressed through a Catholic lens
- Parents notified via email about mature themes; students warned about graphic content and can request alternatives. 30 days allows them advance warning, and option for alternate text
- Teachers and administration emphasized the educational and moral value of the novel, highlighting its role in developing empathy, critical thinking, and moral discernment.

A formal motion to reconsider the novel's inclusion was discussed and defeated by vote.
